- Restricted stock unit vests on a one-to-one share basis 50% on February 8, 2015 and 50% on February 8, 2016.
- Restricted stock unit vest on a one-to-one share basis 50% on February 2, 2014 and 50% on February 2, 2015.
- Restricted stock unit vest on a one-to-one share basis on February 3, 2014.
