Does not include 136,500 shares of common stock issuable upon the vesting of performance-based restricted stock units granted on February 4, 2008. Does not include 54,500 shares of common stock issuable upon the vesting of time-based restricted stock units granted on February 3, 2010. Does not include 24,000 shares of common stock issuable upon the vesting of performance-based restricted stock units granted on February 2, 2011.
- Represents shares withheld to satisfy Mr. Reed's tax withholding obligation with respect to 170,000 shares of common stock issued upon vesting of performance-based restricted stock units, which were awarded to Mr. Reed on May 8, 2003.
- Held as Trustee for Samuel A. Reed Trust UA December 27, 2001.
- Mr. Reed elected to defer vesting of the restricted stock units, which were scheduled to vest on February 1, 2008 until December 31, 2011.
